NEW MEMBERSHIP

TRIAL MEMBERSHIP: Trial memberships are available in all membership categories below. This membership allows prospective Club members to defer the initiation fee one year. This category is only available to those who have not previously been members. Trial members have access to all program areas (golf course, pool, tennis courts, footgolf) when classes or leagues are not underway. Greens fees are waived. Trial members do not have voting rights during the annual board meeting and election.

FULL MEMBERSHIP (20% Discount): New prospective members may choose to begin a full membership including voting rights and initiation fee. These members will receive 20% off the 1st year membership dues and will begin paying the initiation fee immediately. This category has all the rights included below, simply choose your membership category.

MEMBERSHIP RENEWAL

All members have access to all program areas (golf course, pool, tennis courts) when classes or leagues are not underway. Greens fees are waived. The membership holder may vote during the annual board meeting and election (except for Junior and Inactive members). The initiation fee is \$1,000.

FAMILY MEMBERSHIP: Entitles member privileges to the membership holder and a spouse/significant other that resides in the same household. All additional members listed on the application must be children that can be claimed as dependents, stepchildren, or individuals under legal guardianship of the membership holder or spouse/significant other.

2-PERSON MEMBERSHIP: Entitles member privileges to the membership holder and one additional named person that resides in the same household.

INDIVIDUAL MEMBERSHIP: Entitles one person (21+ years of age) membership privileges.

SENIOR MEMBERSHIP: Entitles one person (60+ years of age) membership privileges.

SENIOR 2-PERSON MEMBERSHIP: One of the members must be 60+ years of age. Entitles member privileges to the membership holder and one additional person that is either a spouse/significant other (that has resided in the household for a minimum of 12 months), child claimed as a dependent, stepchild or individual under the legal guardianship of the membership holder.

JUNIOR MEMBERSHIP: Entitles one person (entering the 9th grade through age 20) full membership privileges. Student identification or a driver's license must be presented at the time of registration. This membership category is not subject to the initiation fee. The membership holder is not eligible to vote during the annual board meeting and election.

INACTIVE MEMBERSHIP: This allows current members to put the membership on hold for one season. This may be utilized **only once** during the term of the membership. Members must submit the application and payment before the membership renewal deadline or the membership will expire. In the event a membership expires, all applicable fees will be assessed to renew the membership. Inactive members do not have voting rights during the annual board meeting and election.
